YAC Overview

The Youth Activity Center is open to all Glendale Residents in Grades 4th-8th. The purpose of YAC is to provide children with a safe place to participate in a variety of supervised activities which include open gym basketball, billiards, and other games. The Commons will be used for all activity centers. The pool will be open for designated activity centers. (See the Glen Hills calendar for these dates).

The cost to attend YAC is \$15 which covers admission to all events for the entire year. After payment is received, your child will be issued a YAC card which must be shown to attend each event.

Payment can be made online through the Infinite Campus portal.

Parent Application

1. All students will be given a hard copy of the YAC application from their homeroom teacher. Parents can also get access to the application by clicking on this [LINK](#) or you can pick up a hard copy in the school office. **Parents, please volunteer for one or more event.** Parents or guardian signatures are required on all applications.
2. Please pay the YAC fee of \$15 which includes attendance to **all** YAC events.
3. Your child will receive a special mark on their student ID card upon completion of application and payment.

DROP OFF PROCEDURES

All activity centers start at 7:00 PM and end at 9:00 PM

Parents must drop your child off at the Main (front) entrance.

Please do not drop your child off more than **15 minutes** before the start of the event. Doors will be locked.

Students must have their YAC card to enter.

PICK UP PROCEDURES

Pick up your child up at the front (main) entrance.

You must park your car and walk over to the building and escort your child to the car. You may come 5-10 minutes early and enter the building.

There are no Drive-up Pick-ups. This is for the safety of your child.

The students will wait for pick-ups inside the school (commons area) at the main entrance area.

Please pick-up your child promptly at 9:00.

YAC Covid Safety Protocols

Masks

Masks may be required for all students and parent chaperones attending YAC events. This decision will be based on the current numbers of positive cases in the Northshore area. If required, there will be designated “mask break” areas for students and chaperones that need to take their mask off for a period of time.

Personal Hygiene and Handwashing

Students, and parent chaperones are encouraged to follow proper hand washing procedures using soap and water or hand sanitizers that will be available throughout the building.

Physical Distancing

Students and parent chaperones are expected to follow social distance protocols in all areas of the school building, when possible. Frequent reminders will be used to reinforce this expectation.

Cleaning and Disinfecting

All games and athletic equipment used will be sanitized before and after YAC events. YAC student representatives will help in this capacity.

Water Fountains and Restrooms

Water fountain usage is limited. Students will have access to the bottle filler; the spouts are locked and unavailable for use. Students are encouraged to bring their own water bottle to all YAC events. Please make sure the student's name is clearly labeled on their water bottle. Bottled water will also be available for students to purchase.

Snack Policies

Students can purchase snacks at all YAC events. Students can take off their masks while they are actively eating and/or drinking.

Parent Volunteers

Please be advised that additional Covid protocols might be implemented based on the current CDC guidelines. These could include proof of vaccination and/or negative test results.
